

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-1062

Affirmed
Benefits Allowed in Part, Denied in Part

PROCEDURAL HISTORY: On November 8, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work during the weeks including October 17, 2021 through October 30, 2021 (weeks 42-21 through 43-21) and therefore was ineligible to receive unemployment insurance benefits for those weeks and until the reason for the denial had ended (decision # 90945). Claimant filed a timely request for hearing. On December 6, 2021, ALJ Roberts conducted a hearing and issued Order No. 21-UI-181180, modifying decision # 90945 by concluding that claimant was not able to work, and therefore ineligible to receive benefits, during the weeks including October 17, 2021 through November 20, 2021 (weeks 42-21 through 46-21), but that claimant was able to work, and therefore eligible to receive benefits, for the week of November 21, 2021 through November 27, 2021 (week 47-21). On December 9, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-181180 is affirmed.
