

**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-1064-R**

*Request for Reconsideration Dismissed*

**PROCEDURAL HISTORY AND FINDINGS OF FACT:** On September 10, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective August 15, 2021 (decision # 82541). Claimant filed a timely request for hearing. On October 29, 2021, ALJ Wardlow conducted a hearing at which the employer failed to appear, and issued Order No. 21-UI-178539, affirming decision # 82541. On November 8, 2021, claimant filed an application for review with the Employment Appeals Board (EAB). On December 17, 2021, EAB issued EAB Decision 2021-EAB-1064, affirming Order No. 21-UI-178539. On December 24, 2021, claimant filed a request for reconsideration of EAB Decision 2021-EAB-1064 with EAB. This decision is issued pursuant to EAB's authority under ORS 657.290(3).

**CONCLUSIONS AND REASONS:** Claimant's request for reconsideration is dismissed.

ORS 657.290(3) authorizes the EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20<sup>th</sup> day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

On December 24, 2021, claimant filed a request for reconsideration of EAB Decision 2021-EAB-1064 with EAB, which was timely because it was filed before the 20th day after the decision sought to be reconsidered was mailed. However, claimant's request for reconsideration did not include a statement or otherwise indicate that claimant provided a copy of the request for reconsideration to the employer. The reconsideration request is therefore dismissed for failure to serve a copy of the request for reconsideration on the other party as required by OAR 471-041-0145(2)(a).

**DECISION:** The request for reconsideration filed December 24, 2021 is dismissed. EAB Decision 2021-EAB-1064 and Order No. 21-UI-178539 remain undisturbed.
