

EMPLOYMENT APPEALS BOARD DECISION
2021-EAB-1065

Affirmed
Ineligible Weeks 35-21 through 47-21

PROCEDURAL HISTORY: On September 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was unavailable for work during the week of August 29, 2021 through September 4, 2021 (week 35-21) and therefore ineligible to receive unemployment insurance benefits for that week and until the reason for the denial had ended (decision # 134903). Claimant filed a timely request for hearing. On December 2, 2021, ALJ Murdock conducted a hearing, and on December 3, 2021 issued Order No. 21-UI-181083, modifying decision # 134903 by concluding that claimant was unavailable for work during the weeks including August 29, 2021 through November 27, 2021 (weeks 35-21 through 47-21) and therefore ineligible to receive benefits for those weeks. On December 14, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-181083 is affirmed.
