**EMPLOYMENT APPEALS BOARD DECISION**  
**2021-EAB-1080**

*Affirmed*  
*Request for Hearing Allowed*  
*Ineligible Weeks 27-19 through 44-19*  
*Overpayment Assessed*

**PROCEDURAL HISTORY:** On January 11, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received benefits to which he was not entitled and assessing an overpayment of \$5,544 because claimant was not able to work during the weeks including June 30, 2019 through November 2, 2019 (weeks 27-19 through 44-19) and therefore was not eligible to receive unemployment insurance benefits for those weeks (decision # 154204). On February 1, 2021, decision # 154204 became final without claimant having filed a request for hearing. On October 24, 2021, claimant filed a late request for hearing on decision # 154204. On November 18, 2021, ALJ Monroe conducted a hearing, which was continued on December 6, 2021. On December 10, 2021, ALJ Monroe issued Order No. 21-UI-181584, concluding that claimant had filed a timely request for hearing on decision # 154204 and affirming decision # 154204 on the merits.<sup>1</sup> On December 14, 2021, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-181584 is affirmed.

<sup>1</sup> The order under review concluded that claimant “is not eligible to receive benefits for the period June 30, 2019 through November 2, 2019 (weeks 17/19 – 44/19)[.]” Order No. 21-UI-181584 at 7. The week commencing on June 30, 2019 is week 27-19, not week 17-19. As the dates of ineligibility cited in the conclusion matches the dates cited in decision # 154204, the reference to “week 17/19” is presumed to be scrivener’s error.
