EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-1081

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work during the weeks including July 11, 2021 through September 4, 2021 (weeks 28-21 through 35-21) and was therefore not eligible to receive unemployment insurance benefits for those weeks and until the reason for the denial had ended (decision # 155824). Claimant filed a timely request for hearing. On October 13, 2021, ALJ Hoppe conducted a hearing, and on October 15, 2021 issued Order No. 21-UI-177341, modifying decision # 155824 by concluding that claimant was not able to work, and therefore not eligible to receive benefits, for the weeks including July 11, 2021 through September 25, 2021 (weeks 28-21 through 38-21). On November 4, 2021, Order No. 21-UI-177341 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 15, 2021, claimant filed a late application for review of Order No. 21-UI-177341 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of a web form claimant submitted to EAB, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-177341, mailed to claimant on October 15, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-177341 at 2. Order No. 21-UI-177341 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before November 4, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-177341 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-177341 was due by November 4, 2021. Because claimant did not file their application for review until December 15, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 15, 2021 is dismissed. Order No. 21-UI-177341 remains undisturbed.
