# EMPLOYMENT APPEALS BOARD DECISION 2021-EAB-1087

#### Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On April 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was disqualified from receiving unemployment insurance benefits effective March 28, 2021 (decision # 162414). Claimant filed a timely request for hearing. On May 21, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for June 3, 2021 at 10:45 a.m. On June 3, 2021, claimant failed to appear at the hearing, and ALJ Murdock issued Order No. 21-UI-168094, dismissing claimant's request for hearing due to his failure to appear. On June 15, 2021, claimant filed a timely request to reopen the hearing. On October 26, 2021, OAH served notice of a hearing scheduled for November 9, 2021 at 8:15 a.m. to determine whether claimant had good cause to reopen the June 3, 2021 hearing and, if so, the merits of decision # 162414. On November 9, 2021, ALJ Monroe conducted a hearing, and on November 18, 2021 issued Order No. 21-UI-179981, denying claimant's request to reopen the June 3, 2021 hearing and leaving decision # 162414 undisturbed. On December 8, 2021, Order No. 21-UI-179981 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 16, 2021, claimant filed a late application for review of Order No. 21-UI-179981 with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-179981, mailed to claimant on November 18, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-179981 at 4. Order No. 21-UI-179981 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 8, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-179981 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-

0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-179981 was due by December 8, 2021. Because claimant did not file his application for review until December 16, 2021, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe the circumstances that prevented him from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed December 16, 2021 is dismissed. Order No. 21-UI-179981 remains undisturbed.
