

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0002

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On April 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective February 16, 2020 (decision # 80523). On May 13, 2020, decision # 80523 became final without claimant having filed a request for hearing. On August 29, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 3, 2021 issued Order No. 21-UI-173980, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 17, 2021. On September 9, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response to the appellant questionnaire, and on December 13, 2021 issued Order No. 21-UI-181734, canceling Order No. 21-UI-173980 and re-dismissing claimant's late request for hearing as without good cause, leaving decision # 80523 undisturbed. On December 20, 2021, claimant filed an application for review of Order No. 21-UI-181734 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-181734 is affirmed.
