

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0035

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On May 24, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was therefore disqualified from receiving unemployment insurance benefits effective April 25, 2021 (decision # 172755). On June 14, 2021, decision # 172755 became final without claimant having filed a request for hearing. On June 22, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on August 26, 2021 issued Order No. 21-UI-173469, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 9, 2021. On September 9, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response to the appellant questionnaire, and on December 9, 2021 issued Order No. 21-UI-181516, canceling Order No. 21-UI-173469 and re-dismissing claimant's late request for hearing as without good cause, leaving decision # 172755 undisturbed. On December 29, 2021, claimant filed an application for review of Order No. 21-UI-181516 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-181516 is affirmed.
