EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0039

Affirmed Ineligible Weeks 35-21 through 38-21

PROCEDURAL HISTORY: On September 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of August 29, 2021 through September 4, 2021 (week 35-21), and until the reason for the denial had ended. Claimant filed a timely request for hearing. On December 9, 2021, ALJ Messecar conducted a hearing, and on December 16, 2021 issued Order No. 21-UI-182044, modifying the September 23, 2021 administrative decision by concluding that claimant was ineligible to receive benefits for the weeks including August 29, 2021 through September 25, 2021 (weeks 35-21) through 38-21).¹ On January 3, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant submitted two substantively identical written arguments on January 4, 2022 and January 24, 2022. EAB considered claimant's arguments when reaching this decision. In the arguments, claimant argued that he should not have been determined to be ineligible for benefits because of ORS 657.159(3), which calls for the Department to consider, among other things, the employer affiliation of a claimant when determining what information a claimant must submit to satisfy their work registration requirement. ORS 657.159(3) does not change the result in this case. Here, ORS 657.155(1)(a) states in pertinent part that an unemployed individual is eligible to receive benefits only if the individual has registered for work. ORS 657.159(1) states that to satisfy the registration requirement of ORS 657.155(1), an individual shall submit such information regarding the individual's job qualifications, training and experience as the Department requests. Under OAR 471-030-0035(1) (January 11, 2018), claimant may satisfy the "registered for work" requirements of ORS 657.155(1)(a) by completion of such processes as directed by the Department in order to create a full registration for work.

¹ Although the order under review characterized its disposition as affirming the September 23, 2021 administrative decision, it actually modified the administrative decision because it altered the weeks for which claimant was denied benefits. Order No. 21-UI-182044 at 4.

The order under review correctly concluded that claimant failed to complete the processes necessary to create a full registration for work and therefore claimant was not eligible to receive benefits for the weeks at issue. Order No. 21-UI-182044 at 4. Although OAR 471-030-0035(3) states that the provisions of OAR 471-030-0035 do not apply to a "partially unemployed individual," the requirements of OAR 471-030-0035(1) were applicable to claimant because he did not meet the definition of a partially unemployed individual given that he did not perform any work during the weeks at issue. *See* OAR 471-030-0060(1)(b) (January 11, 2018) ("partially unemployed individual" defined in part as someone who "[n]ow works some but less than their customary full time hours"). For these reasons, the findings and conclusions of the order under review are correct and are being adopted by this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 21-UI-182044 is affirmed.
