

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0042**

*Affirmed*  
*Request to Reopen Denied*

**PROCEDURAL HISTORY:** On June 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of May 30, 2021 through June 5, 2021 (week 22-21) (decision # 63813). On July 20, 2021, decision # 63813 became final without claimant having filed a request for hearing. On July 27, 2021 claimant filed a late request for hearing. On August 10, 2021, the Office of Administrative Hearings (OAH) served notice of a hearing scheduled for August 24, 2021 at 8:15 a.m. On August 24, 2021, claimant failed to appear at the hearing, and ALJ Frank issued Order No. 21-UI-173224, dismissing claimant's request for hearing for failure to appear. On September 13, 2021, claimant filed a timely request to reopen the hearing. ALJ Kangas reviewed claimant's request to reopen, and on December 20, 2021, issued Order No. 21-UI-182302, denying claimant's request to reopen the hearing and leaving Order No. 21-UI-173224 undisturbed. On December 29, 2021, claimant filed an application for review of Order No. 21-UI-182302 with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 21-UI-182302 is affirmed.
