

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0044

Late Application for Review Dismissed

PROCEDURAL HISTORY: On September 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had not actively sought work during the weeks including August 1, 2021 through September 18, 2021 (weeks 31-21 through 37-21), and was therefore not eligible to receive unemployment insurance benefits for those weeks (decision # 81720). Claimant filed a timely request for hearing. On November 30, 2021, ALJ Lucas conducted a hearing, and on December 3, 2021 issued Order No. 21-UI-181034, affirming decision # 81720. On December 23, 2021, Order No. 21-UI-181034 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On December 31, 2021, claimant filed a late application for review of Order No. 21-UI-181735 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-181034, mailed to claimant on December 3, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-181034 at 4. Order No. 21-UI-181034 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before December 23, 2021 to be timely.”

CONCLUSIONS AND REASONS: Claimant’s late application for review of Order No. 21-UI-181034 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-181034 was due by December 23, 2021. Because claimant did not file their application for review until December 31, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the December 23, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 31, 2021 is dismissed. Order No. 21-UI-181034 remains undisturbed.
