

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0051**

*Order No. 21-UI-182754 Affirmed ~ Ineligible Weeks 47-20 through 51-20*  
*Order No. 21-UI-182756 Affirmed ~ Ineligible Weeks 01-21 through 02-21*  
*Order No. 21-UI-182755 Affirmed ~ Ineligible Weeks 04-21 through 11-21*

**PROCEDURAL HISTORY:** On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including November 15, 2020 through December 19, 2020 (weeks 47-20 through 51-20) and therefore was denied benefits for those weeks (decision # 144915). Also on July 6, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks including January 3, 2021 through January 16, 2021 (weeks 01-21 through 02-21) and therefore was denied benefits for those weeks (decision # 145349). Also on July 6, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks including January 24, 2021 through March 20, 2021 (weeks 04-21 through 11-21) and therefore was denied benefits for those weeks (decision # 145540). Claimant filed timely requests for hearing on decisions # 144915, 145349, and 145540. On December 22, 2021, ALJ Roberts conducted a consolidated hearing on decisions # 144915, 145349, and 145540, and on December 28, 2021 issued Orders No. 21-UI-182754, 21-UI-182756, and 21-UI-182755, affirming decisions # 144915, 145349, and 145540, respectively. On January 4, 2022, claimant filed timely applications for review of Orders No. 21-UI-182754, 21-UI-182756, and 21-UI-182755 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-182754, 21-UI-182756, and 21-UI-182755. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2021-EAB-0051, 2021-EAB-0049, and 2021-EAB-0050).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 21-UI-182754, 21-UI-182756, and 21-UI-182755 are affirmed.
