

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0062

*Orders No. 21-UI-182060, 21-UI-082058, and 21-UI-182066 Affirmed ~
Eligible Weeks 35-21 and 36-21, Ineligible Weeks 25-21 through 34-21 and 38-21*

PROCEDURAL HISTORY: On October 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate her restarted claim to June 20, 2021, and concluding that she was therefore ineligible to receive unemployment insurance benefits for the weeks including June 20, 2021 through September 11, 2021 (weeks 25-21 through 36-21) (decision # 122340). Also on October 15, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks including June 20, 2021¹ through August 21, 2021 (weeks 25-21 through 33-21) and therefore was denied benefits for those weeks (decision # 121053). Also on October 15, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the week of September 19, 2021 through September 25, 2021 (week 38-21) and therefore was denied benefits for that week (decision # 122115). Claimant filed timely requests for hearing on decisions # 122340, 121053, and 122115. On December 14, 2021, ALJ Wardlow conducted a consolidated hearing on all three administrative decisions, and on December 16, 2021, issued Order No. 21-UI-182060, modifying decision # 122340 by concluding that claimant was eligible to backdate her reopened claim to August 29, 2021 and therefore eligible for benefits for the weeks including August 29, 2021 through September 11, 2021 (weeks 35-21 and 36-21) but was not eligible for benefits for the weeks including June 20, 2021 through August 28, 2021 (weeks 25-21 through 34-21); Order No. 21-UI-182058, affirming decision # 121053; and Order No. 21-UI-182066, affirming decision # 122115. On January 4, 2022, claimant filed applications for review of Orders No. 21-UI-182060, 21-UI-182058, and 21-UI-182066 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-182060, 21-UI-182058, and 21-UI-182066. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2021-EAB-0062, 2021-EAB-0063, and 2021-EAB-0064).

¹ Decision # 121053 pertained to a period of weeks included in the weeks at issue in decision # 122340. It is not clear from the record why the Department issued both administrative decisions.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 21-UI-182060, 21-UI-082058, and 21-UI-182066 are affirmed.
