EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0076

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 16, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was denied unemployment insurance benefits for the week of July 25, 2021 through July 31, 2021 (week 30-21) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On December 9, 2021, ALJ Murdock conducted a hearing, and on December 13, 2021 issued Order No. 21-UI-181735, modifying the August 16, 2021 administrative decision by concluding that claimant failed to register for work in accordance with the Department's rules and was therefore ineligible for benefits for the weeks including July 25, 2021 through August 28, 2021 (weeks 30-21 through 34-21). On January 3, 2022, Order No. 21-UI-181735 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 6, 2022, claimant filed a late application for review of Order No. 21-UI-181735 with EAB.

WRITTEN ARGUMENT: Claimant filed a written argument on January 8, 2022. EAB considered claimant's argument when reaching this decision. However, claimant's written argument did not describe the circumstances that prevented them from filing the application for review on time.

FINDING OF FACT: (1) Order No. 21-UI-181735, mailed to claimant on December 13, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-181735 at 5. Order No. 21-UI-181735 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 3, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-181735 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-181735 was due by January 3, 2022. Because claimant did not file their application for review until January 6, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the January 3, 2022 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 6, 2022 is dismissed. Order No. 21-UI-181735 remains undisturbed.
