# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0093

Late Application for Review Dismissed No Justiciable Controversy

**PROCEDURAL HISTORY:** On January 7, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and therefore was disqualified from receiving unemployment insurance benefits effective October 25, 2020 (decision # 105957). Claimant filed a timely request for hearing. On December 6, 2021, ALJ S. Lee conducted a hearing at which the employer failed to appear, and on December 9, 2021, issued Order No. 21-UI-181493, reversing decision # 105957 and concluding that claimant was discharged, but not for misconduct, and was not disqualified from receiving benefits. On December 29, 2021, Order No. 21-UI-181493 became final without the employer having filed an application for review with the Employment Appeals Board (EAB). On January 10, 2022, claimant filed a late application for review of Order No. 21-UI-181493 with EAB.

**FINDING OF FACT:** (1) Order No. 21-UI-181493, mailed to claimant on December 9, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-181493 at 4. Order No. 21-UI-181493 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 29, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's application for review of Order No. 21-UI-181493 is dismissed because it is late and because it presents no justiciable controversy.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it

includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-181493 was due December 29, 2021. Because claimant did not file his application for review until January 10, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the December 29, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed for this reason.

In addition, claimant's January 10, 2022 application for review requests review of an order that allowed the appellant benefits. Claimant did not assign error to any portion of Order No. 21-UI-181493, did not request reversal of any portion of the order, and alleged no facts entitling claimant to further relief in this matter. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 21-UI-181493 is dismissed for this reason as well, and Order No. 21-UI-181493 remains undisturbed.

**DECISION:** The application for review filed January 10, 2022 is dismissed. Order No. 21-UI-181493 remains undisturbed.
