EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0095

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged for misconduct and was therefore disqualified from receiving unemployment insurance benefits effective October 25, 2020 (decision # 93353). Claimant filed a timely request for hearing. On December 13, 2021, ALJ McGorrin conducted a hearing, and on December 14, 2021, issued Order No. 21-UI-181795, affirming decision # 93353. On January 3, 2022, Order No. 21-UI-181795 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 12, 2022, claimant filed a late application for review of Order No. 21-UI-181795 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement submitted with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-181795, mailed to claimant on December 14, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-181795 at 4. Order No. 21-UI-181795 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 3, 2022 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-181795 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a

showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-181795 was due by January 3, 2022. Because claimant did not file their application for review until January 12, 2022, the application for review was late. Claimant provided a written statement with the application for review. In their written statement, claimant asserted that they did not realize they had missed the 20-day deadline to file their application for review. EAB Exhibit 1. Order No. 21-UI-181795 stated that an appeal of the order was due within 20 days from the date OAH mailed the order. The order's Certificate of Mailing stated that any appeal was due by January 3, 2022. Claimant's written statement does not show that their failure to read Order No. 21-UI-181795 and its Certificate of Mailing carefully or to understand the applicable filing deadline was a factor or circumstance beyond claimant's reasonable control. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 12, 2022 is dismissed. Order No. 21-UI-181795 remains undisturbed.
