EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0103

Order No. 22-UI-183251 ~ Affirmed ~ Late Claims for Benefits Denied ~ Ineligible Weeks 37-21 through 44-21

Order No. 22-UI-183250 ~ Dismissed ~ No Justiciable Controversy

PROCEDURAL HISTORY: On November 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including September 12, 2021 through November 6, 2021 (weeks 37-21 through 44-21) and therefore was ineligible to receive benefits for those weeks (decision #95909). Also on November 30, 2021, the Department served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of September 19, 2021 through September 25, 2021 (week 38-21), and until the reason for the denial had ended.

On December 7, 2021, claimant filed timely requests for hearing on decision #95909 and the November 30, 2021 administrative decision. On January 4, 2022, ALJ Mott conducted a consolidated hearing, and on January 5, 2022 issued Orders No. 22-UI-183251 and 22-UI-183250, affirming decision #95909 and reversing the November 30, 2021 administrative decision by concluding that claimant did not fail to register for work as directed by the Department and therefore was not ineligible on that basis to receive benefits for the weeks including September 19, 2021 through December 4, 2021 (weeks 38-21 through 48-21). On January 12, 2022, claimant filed applications for review on Orders No. 22-UI-183251 and 22-UI-183250 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-183251 and 22-UI-183250. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0103 and 2022-EAB-0104).

EAB reviewed the entire consolidated hearing record. To the extent claimant's appeal of the orders under review relate to the conclusion that claimant did not fail to register for work as directed by the Department and therefore was not ineligible to receive benefits on that basis, the appeal relates to portions of the order that allowed claimant benefits and there is no justiciable controversy before EAB. As such, those portions of claimant's appeal are dismissed as non-justiciable. The remainder of this decision addresses claimant's appeal of the portions of the orders under review relating to the conclusion

that claimant filed late claims for benefits and therefore was ineligible to receive benefits for the weeks including September 12, 2021 through November 6, 2021. As to those portions of the orders, on *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-183251 and 22-UI-183250 are affirmed in part and dismissed in part, as set forth above.
