

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0114**

*Order No. 21-UI-182856 ~ Affirmed ~ Ineligible Weeks 22-20 through 47-20*  
*Order No. 21-UI-182855 ~ Affirmed ~ Ineligible Weeks 50-20 through 20-21*

**PROCEDURAL HISTORY:** On November 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks including May 24, 2020 through November 21, 2020 (weeks 22-20 through 47-20) and was therefore ineligible to receive benefits for those weeks (decision # 84837). Also on November 23, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for benefits for the weeks including December 6, 2020 through May 22, 2021 (weeks 50-20 through 20-21) and was therefore ineligible to receive benefits for those weeks (decision # 95337). Claimant filed timely requests for hearing on decisions # 84837 and 95337. On December 21, 2021, ALJ Ramey conducted a consolidated hearing on decisions # 84837 and 95337, and on December 28, 2021 issued Orders No. 21-UI-182856 and 21-UI-182855, affirming decisions # 84837 and 95337, respectively. On January 17, 2022, claimant filed applications for review of Orders No. 21-UI-182856 and 21-UI-182855 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-182856 and 21-UI-182855. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0115 and 2022-EAB-0114).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Orders No. 21-UI-182856 and 21-UI-182855 are affirmed.
