

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0116**

*Affirmed*  
*Late Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On March 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant received \$1,812 in Pandemic Emergency Unemployment Compensation (PEUC) and \$600 in Federal Pandemic Unemployment Compensation (FPUC) benefits to which claimant was not entitled and was required to repay because during the weeks claimed, claimant was eligible for other unemployment benefits (decision # 172259). On April 7, 2021, decision # 172259 became final without claimant having filed a request for hearing. On May 10, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on June 2, 2021 issued Order No. 21-UI-167880, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by June 16, 2021. On June 9, 2021, claimant filed a timely response to the appellant questionnaire. On December 8, 2021, the Office of Administrative Hearings (OAH) mailed notice of a hearing scheduled for January 4, 2022 to consider whether claimant's late request for hearing should be allowed and, if so, the merits of decision # 172259. On January 4, 2022, ALJ Frank conducted a hearing, and on January 13, 2022 issued Order No. 22-UI-184004, dismissing claimant's request for hearing as late without good cause and leaving decision # 172259 undisturbed. On January 14, 2022, claimant filed an application for review of Order No. 22-UI-184004 with the Employment Appeals Board (EAB).

**WRITTEN ARGUMENTS:** EAB considered claimant's January 14, 2022 and January 20, 2022 written arguments when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-184004 is affirmed.
