## EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0124

Late Applications for Review Dismissed

**PROCEDURAL HISTORY:** On June 26, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not able to work from March 15, 2020 to March 21, 2020 (week 12-20) and was therefore ineligible to receive unemployment insurance benefits for that week and until the reason for denial had ended (decision # 164818). Also on June 26, 2020, the Department served notice of an administrative decision concluding that claimant failed to provide requested information to the Department and was therefore ineligible to receive unemployment insurance benefits from March 15, 2020 to March 21 2020 (week 12-20) and April 12, 2020 to April 18, 2020 (week 16-20) and until the reason for denial had ended (decision # 121202). On July 16, 2020, decisions # 164818 and # 121202 became final without claimant having filed a request for hearing. On October 8, 2021, claimant filed late requests for hearing on decisions # 164818 and # 121202.

ALJ Kangas considered claimant's requests, and on December 27, 2021 issued Orders No. 21-UI-182703 and 21-UI-182733, dismissing claimant's late requests for hearing on decisions # 164818 and # 121202 as late, subject to claimant's right to renew the requests by responding to appellant questionnaires by January 10, 2022. On January 18, 2022, Orders No. 21-UI-182703 and 21-UI-182733 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 19, 2022, claimant filed late applications for review of Orders No. 21-UI-182703 and 21-UI-182733 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-182703 and 21-UI-182733. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0124 and 2022-EAB-0123).

**FINDINGS OF FACT:** (1) Order No. 21-UI-182703, mailed to claimant on December 27, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-182703 at 2. Order No. 21-UI-182703 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 18, 2022."

(2) Order No. 21-UI-182733, mailed to claimant on December 27, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-182733 at 2. Order No. 21-UI-182733 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than January 18, 2022."

**CONCLUSIONS AND REASONS:** Claimant's late applications for review of Orders No. 21-UI-182703 and 21-UI-182733 are dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-182703 and 21-UI-182733 were due by January 18, 2022. Because claimant did not file their applications for review until January 19, 2022, the applications for review were late. Claimant provided a written statement with the applications for review. However, claimant's written statement did not describe the circumstances that prevented claimant from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

**DECISION:** The applications for review filed January 19, 2022 are dismissed. Orders No. 21-UI-182703 and 21-UI-182733 remain undisturbed.
