

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0125

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On February 11, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On March 3, 2021, the February 11, 2021 administrative decision became final without claimant having filed a request for hearing. On August 18, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 15, 2021 issued Order No. 21-UI-174776, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 29, 2021. On October 4, 2021, the Office of Administrative Hearings (OAH) emailed claimant a copy of Order No. 21-UI-174776 at her email address on file. On October 5, 2021, Order No. 21-UI-17446 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On November 6, 2021, claimant filed a late response to the appellant questionnaire. On January 13, 2022, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, OAH would not consider claimant's late response to the appellant questionnaire or issue another order, and Order No. 21-UI-174776 remained in effect. On January 18, 2022, claimant filed a late application for review of Order No. 21-UI-174776 with EAB.

CONCLUSIONS AND REASONS: The application for review should be dismissed without prejudice.

On January 18, 2022, the appellant filed an application for review of Order No. 21-UI-174776 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than October 5, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. *See* ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

EAB will dismiss any request for reconsideration that does not include **all five** of the following:

1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is March 2, 2022, making the deadline March 22, 2022¹ to file the request for reconsideration, **and**
2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, **and**
3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about the date they received Order No. 21-UI-174776 either when it was mailed to claimant on September 15, 2021 or when it was emailed to claimant on October 4, 2021, whether they read it, whether they agreed or disagreed with Order No. 21-UI-174776, the reason(s) why they did not file the application for review of Order No. 21-UI-174776 before the deadline, how the reason(s) affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had “good cause,” which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review of Order No. 21-UI-174776, **and**
4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, **and**
5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

1. Use your smart phone, tablet, or computer to fill out the “File a Written Argument” form, available on EAB’s website: <https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx>, *or*
2. Use your smart phone, tablet, or computer to send an email to EAB at OED_EAB_OFFICE@employ.oregon.gov, *or*
3. Send the request by U.S. mail or another delivery service, addressed to 875 Union St NE, Salem, Oregon 97311, *or*
4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed January 18, 2022 is dismissed without prejudice. Order No. 21-UI-174776 remains undisturbed.
