EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0126

Late Application for Review Dismissed

PROCEDURAL HISTORY: On July 7, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not provide information following the rules set by the Department and was therefore denied unemployment insurance benefits for the week of June 27, 2021 through July 3, 2021 (week 26-21) (decision #83506). Claimant filed a timely request for hearing. On September 1, 2021, ALJ Roberts conducted a hearing and issued Order No. 21-UI-173814, modifying¹ decision #83506 by concluding that claimant did not provide information following the rules set by the Department and was therefore denied benefits for the weeks including July 4, 2021 through August 21, 2021 (weeks 27-21 through 33-21). On September 21, 2021, Order No. 21-UI-173814 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 20, 2022, claimant filed a late application for review of Order No. 21-UI-173814 with EAB.

FINDING OF FACT: (1) Order No. 21-UI-173814, mailed to claimant on September 1, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-173814 at 4-5. Order No. 21-UI-173814 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before September 21, 2021 to be timely."

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-173814 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing

ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-173814 was due September 21, 2021. Because claimant did not file their application for review until January 20, 2022, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented claimant from filing the application for review by the September 21, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed January 20, 2022 is dismissed. Order No. 21-UI-173814 remains undisturbed.
