

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0137**

*Order No. 22-UI-183680 ~ Affirmed ~ Ineligible Weeks 21-21 and 22-21*  
*Order No. 22-UI-183679 ~ Affirmed ~ Ineligible Weeks 24-21 through 29-21*  
*Order No. 22-UI-183681 ~ Affirmed ~ Ineligible Weeks 38-21 through 45-21*

**PROCEDURAL HISTORY:** On December 8, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant's request to backdate her claim was denied and she was therefore ineligible to receive unemployment insurance benefits from May 23, 2021 through June 5, 2021 (weeks 21-21 and 22-21) (decision # 125927). Also on December 8, 2021, the Department served notice of an administrative decision concluding that claimant's request to backdate her claim was denied and she was therefore ineligible to receive unemployment insurance benefits from June 13, 2021 through July 24, 2021 (weeks 24-21 through 29-21) (decision # 130750). Also on December 8, 2021, the Department served notice of an administrative decision concluding that claimant filed late claims for unemployment insurance benefits for the weeks of September 19, 2021 through November 13, 2021 (weeks 38-21 through 45-21) and was therefore ineligible to receive benefits for those weeks (decision # 131131). Claimant filed timely requests for hearing on decisions # 125927, 130750, and 131131. On January 6, 2022, ALJ Ramey conducted a consolidated hearing, and on January 10, 2022 issued Orders No. 22-UI-183680, 22-UI-183679 and 22-UI-183681, affirming decisions # 125927, 130750 and 131131. On January 22, 2022, claimant filed applications for review of Orders No. 22-UI-183680, 22-UI-183679, and 22-UI-183681 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-183680, 22-UI-183679, and 22-UI-183681. For case-tracking purposes, this decision is being issued in triplicate (EAB Decisions 2022-EAB-0136, 2022-EAB-0135 and 2022-EAB-0137).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 22-UI-183680, 22-UI-183679, and 22-UI-183681 are affirmed.
