

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0148

Affirmed
Request to Backdate Initial Claim Denied

PROCEDURAL HISTORY: On July 16, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate his initial claim to March 28, 2021, and concluding that he was therefore ineligible to receive unemployment insurance benefits for the weeks from March 28, 2021 through May 1, 2021 (weeks 13-21 through 17-21) (decision # 81821). Claimant filed a timely request for hearing. On December 30, 2021, ALJ Roberts conducted a hearing, and on January 5, 2022 issued Order No. 22-UI-183322, affirming decision # 81821. On January 24, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant asserted in his written argument that because "backdating may occur based on evidence of the individual's documented contact on the prior date with the Employment Department," that claimant's initial claim for the weeks at issue should be backdated to April 11, 2021, when claimant had a documented contact with the Department. Claimant's initial claim cannot be backdated to April 11, 2021 because the April 11, 2021 was not an attempt to file an initial claim. Rather, the record shows that it was an attempt to claim weeks on a prior claim that ended on April 3, 2021. OAR 471-030-0040(1)(e) (January 11, 2018) allows backdating to correct, adjust, or reset the filing of an initial, additional, or reopened claim. Here, claimant did not attempt to file an initial claim on April 11, 2021, so it is not appropriate to backdate to correct, adjust, or reset the "filing of an initial claim" to that date.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-183322 is affirmed.
