

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0156**

*Order No. 22-UI-183159 Affirmed ~ Disqualification*  
*Order No. 22-UI-183162 Affirmed ~ Disqualification*  
*Order No. 22-UI-183164 Affirmed ~ Disqualification*  
*Order No. 22-UI-183165 Affirmed ~ Ineligible Weeks 02-21 through 30-21*

**PROCEDURAL HISTORY:** On June 28, 2021, the Department served notice of an administrative decision concluding that claimant refused an offer of suitable work without good cause and was disqualified from receiving unemployment insurance benefits effective April 25, 2021 (decision # 83534). Also on June 28, 2021, the Department served notice of an administrative decision concluding that claimant refused an offer of suitable work without good cause and was disqualified from receiving benefits effective May 23, 2021 (decision # 120248). Also on June 28, 2021, the Department served notice of an administrative decision concluding that claimant refused an offer of suitable work without good cause and was disqualified from receiving benefits effective April 25, 2021 (decision # 122301). Also on June 28, 2021, the Department served notice of an administrative decision concluding that claimant was not available for work beginning January 10, 2021 (week 02-21) and was therefore not eligible to receive unemployment insurance benefits for that week and until the reason for the denial had ended (decision # 72828).

On July 12, 2021, claimant filed a timely request for hearing on decisions # 83534, 120248, 122301, and 72828. On December 30, 2021, ALJ Janzen conducted a consolidated hearing on all four administrative decisions, and on January 4, 2022, served Order No. 22-UI-183159, affirming decision # 83534; Order No. 22-UI-183162, affirming decision # 120248; Order No. 22-UI-183164, affirming decision # 122301; and Order No. 22-UI-183165, modifying decision # 72828 by concluding that claimant was not available for work during the weeks including January 10, 2021 through July 31, 2021 (weeks 02-21 through 30-21) and was therefore not eligible to receive benefits for those weeks.<sup>1</sup> On January 24, 2022,

claimant filed an application for review of Orders No. 22-UI-183159, 22-UI-183162, 22-UI-183164, and 22-UI-183165 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-183159, 22-UI-183162, 22-UI-183164, and 22-UI-183165. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2022-EAB-0156, 2022-EAB-0157, 2022-EAB-0158, and 2022-EAB-0159).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-183159 is affirmed.
