

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0161

Affirmed
Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On December 10, 2020, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective February 2, 2020. On December 30, 2020, the December 10, 2020 administrative decision became final without claimant having filed a request for hearing. On August 5, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on September 9, 2021 issued Order No. 21-UI-174417, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by September 23, 2021. On September 21, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on January 5, 2022 issued Order No. 22-UI-183241, canceling and replacing Order No. 21-UI-174417, re-dismissing claimant's request for hearing as late without good cause, and leaving the December 10, 2020 administrative decision undisturbed. On January 25, 2022, claimant filed an application for review of Order No. 22-UI-183241 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented them from offering the information into the hearing record in their response to the appellant questionnaire attached to Order No. 21-UI-174417. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-183241 is affirmed.
