

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0166

*Orders No. 22-UI-183456, 22-UI-183454, 22-UI-183445, and 22-UI-183450 Affirmed
Requests to Backdate Initial Claim Denied*

PROCEDURAL HISTORY: On November 30, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision denying claimant's request to backdate her initial claim to March 28, 2021, and concluding that she was therefore ineligible to receive unemployment insurance benefits for the weeks including March 28, 2021 through May 22, 2021 (weeks 13-21 through 20-21) (decision # 63422). Also on November 30, 2021, the Department served notice of an administrative decision denying claimant's request to backdate her initial claim to May 23, 2021, and concluding that she was therefore ineligible to receive unemployment insurance benefits for the weeks including May 23, 2021 through July 17, 2021 (weeks 21-21 through 28-21) (decision # 65116). Also on November 30, 2021, the Department served notice of an administrative decision denying claimant's request to backdate her initial claim to July 18, 2021, and concluding that she was therefore ineligible to receive unemployment insurance benefits for the weeks including July 18, 2021 through July 31, 2021 (weeks 29-21 through 30-21) (decision # 70045). Also on November 30, 2021, the Department served notice of an administrative decision denying claimant's request to backdate her initial claim to January 31, 2021, and concluding that she was therefore ineligible to receive unemployment insurance benefits for the weeks including January 31, 2021 through March 27, 2021 (weeks 05-21 through 12-21) (decision # 55019). Claimant filed timely requests for hearing on decisions # 63422, 65116, 70045, and 55019.

On December 29, 2021, ALJ Ramey conducted a consolidated hearing on decisions # 63422, 65116, 70045, and 55019, and on January 6, 2022 issued Orders No. 22-UI-183456, 22-UI-183454, 22-UI-183445, and 22-UI-183450, affirming decisions # 63422, 65116, 70045, and 55019, respectively. On January 24, 2022, claimant filed applications for review of Orders No. 22-UI-183456, 22-UI-183454, 22-UI-183445, and 22-UI-183450 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-183456, 22-UI-183454, 22-UI-183445, and 22-UI-183450. For case-tracking purposes, this decision is being issued in quadruplicate (EAB Decisions 2022-EAB-0163, 2022-EAB-0164, 2022-EAB-0165, and 2022-EAB-0166).

WRITTEN ARGUMENT: EAB considered claimant's written argument when reaching this decision.

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-183456, 22-UI-183454, 22-UI-183445, and 22-UI-183450 are affirmed.
