2022-EAB-0168

Order No. 22-UI-184618 ~ Affirmed ~ Ineligible for TUI Benefits
Order No. 22-UI-184619 ~ Affirmed ~ Ineligible for TUI Benefits

PROCEDURAL HISTORY: On October 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not eligible to receive Training Unemployment Insurance (TUI) benefits for the period claimed (decision # 113610). On October 25, 2021, the Department served notice of an administrative decision concluding that claimant was not eligible to receive TUI benefits for the period claimed (decision # 110444). Claimant filed timely requests for hearing on decisions # 113610 and 110444. On January 20, 2022, ALJ Janzen conducted a consolidated hearing, and on January 24, 2022 issued Orders No. 22-UI-184618 and 22-UI-184619, affirming decisions # 113610 and 110444, respectively. On January 26, 2022, claimant filed applications for review of Orders No. 22-UI-184618 and 22-UI-184619 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-184618 and 22-UI-184619. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0168 and 2022-EAB-0167).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-184618 and 22-UI-184619 are affirmed.
