EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0177

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On July 23, 2020, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective February 9, 2020 (decision #61651). On August 12, 2020, decision #61651 became final without claimant having filed a request for hearing. On November 13, 2020, the Department served notice of an administrative decision, based in part on decision #61651, concluding that claimant received benefits to which they were not entitled, and assessing an overpayment of \$5,250 in regular unemployment insurance benefits and \$2,400 in Federal Pandemic Unemployment Compensation (FPUC) benefits that claimant was liable to repay to the Department (decision #110431). On December 3, 2020, decision #110431 became final without claimant having filed a request for hearing. On March 9, 2021, claimant filed late requests for hearing on decisions #61651 and 110431. ALJ Kangas considered claimant's requests, and on March 31, 2021 issued Orders No. 21-UI-163840 and 21-UI-163844 dismissing claimant's requests for hearing on decisions #61651 and 110431 as late, subject to claimant's right to renew the requests by responding to an appellant questionnaire by April 14, 2021. On April 20, 2021, Orders No. 21-UI-163840 and 21-UI-163844 became final without claimant filed an appellant questionnaire response or applications for review of Orders No. 21-UI-163840 and 21-UI-163844 with the Employment Appeals Board (EAB). On November 17, 2021, claimant filed a late appellant questionnaire response and late applications for review of Orders No. 21-UI-163840 and 21-UI-163844 with EAB. On January 26, 2022, ALJ Kangas mailed letters to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and that Orders No. 21-UI-163840 and 21-UI-163844 remained in effect. This matter comes before EAB based upon claimant's November 17, 2021 applications for review of Orders No. 21-UI-163840 and 21-UI-163844.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-163840 and 21-UI-163844. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0177 and 2022-EAB-0178).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided

to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 21-UI-163840, mailed to claimant on March 31, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-163840 at 2. Order No. 21-UI-163840 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 20, 2021."

(2) Order No. 21-UI-163844, mailed to claimant on March 31, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-163844 at 2. Order No. 21-UI-163844 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than April 20, 2021."

CONCLUSIONS AND REASONS: Claimant's late applications for review of Orders No. 21-UI-163840 and 21-UI-163844 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-163840 and 21-UI-163844 were due by April 20, 2021. Because claimant did not file their applications for review until November 17, 2021, the applications for review were late. Claimant provided a written statement with the applications for review. EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review of Orders No. 21-UI-163840 and 21-UI-163844 are dismissed.

DECISION: The applications for review filed November 17, 2021 are dismissed. Orders No. 21-UI-163840 and 21-UI-163844 remain undisturbed.
