EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0185

Late Application for Review Dismissed Without Prejudice

PROCEDURAL HISTORY AND FINDINGS OF FACT: On April 22, 2021, the Oregon Employment Department (the Department) served notice of a Wage and Potential Benefit Report concluding that claimant did not qualify for unemployment insurance benefits because they had not worked sufficient hours or earned enough wages in their base year. On May 2, 2021, the April 22, 2021 administrative decision became final without claimant having filed a request for hearing. On May 14, 2021, claimant filed a late request for hearing on the April 22, 2021 administrative decision. ALJ Kangas considered claimant's request, and on June 17, 2021 issued Order No. 21-UI-168988, dismissing claimant's request for hearing as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by July 1, 2021. On July 7, 2021, Order No. 21-UI-168988 became final without claimant having filed a response to the appellant questionnaire with the Office of Administrative Hearings (OAH) or an application for review with the Employment Appeals Board (EAB). On January 28, 2022, claimant filed a late application for review with EAB.

CONCLUSIONS AND REASONS: The application for review is dismissed without prejudice.

On January 28, 2022, the appellant filed an application for review of Order No. 21-UI-168988 with EAB. ORS 657.270(6) and ORS 657.270(7)(b) required the application for review to be filed no later than July 7, 2021. The appellant's application for review is therefore late, and this application for review is dismissed.

The deadline for filing an application for review may be extended a reasonable time upon a showing of good cause. See ORS 657.875; OAR 471-041-0070 (May 13, 2019). If the appellant believes they have good cause and filed their late application for review within a reasonable time, the appellant may request that EAB reconsider this decision under OAR 471-041-0145 (May 13, 2019).

On their application for review, in response to a question requesting an explanation for why a party failed to appear at a hearing, claimant stated, "No one informed me or my lawyer about the hearing so how could I appear?" despite the fact that no hearing was held. EAB Exhibit 1. Additionally, on the application for review, claimant entered the case number—"2021-UI-34847"—instead of the number of the order under review (21-UI-168988), and "01/07/2022" in the "Date Order Mailed" field, despite the

fact that the order under review was mailed on June 17, 2021. EAB Exhibit 1. Claimant also did not submit a response to the appellant questionnaire, which was mailed with the order under review. In short, claimant's application for review and the statement written on the application for review contain no references to the order under review or a recognition that no hearing was actually held on the April 22, 2021 administrative decision, suggesting that claimant may not have received a copy of Order No. 21-UI-168988.

EAB will dismiss any request for reconsideration that does not include all five of the following:

- 1. The appellant must file the request for reconsideration within 20 days of the date this decision was mailed; the date this decision was mailed is March 16, 2022, making the deadline **April 5**, **2022**¹ to file the request for reconsideration, *and*
- 2. The appellant must include a statement on the request for reconsideration declaring that they sent a copy of the request to the other party, *and*
- 3. The appellant must provide additional specific details about the reason they filed a late application for review. For example, the appellant should include specific information about whether they received Order No. 21-UI-168988, and, if so, the date they received the ALJ's order, whether they read it, whether they agreed or disagreed with the ALJ's order, the reason(s) why they did not file the application for review before the deadline, how the reason(s) affected their ability to file a timely application for review, whether they or their families were ill or quarantined around the deadline, whether they could not file a timely application for review for any other reason(s) not related to illness or quarantine, how that affected their ability to file a timely application for review, and any other specific details that might help EAB determine whether or not the appellant had "good cause," which means factors or circumstances beyond their reasonable control prevented them from filing a timely application for review, and
- 4. The appellant must provide the date the circumstances that prevented them from filing a timely application for review (which they listed in response to #3, above) ceased to exist, *and*
- 5. The appellant must provide sufficient information to prove that they filed their application for review within seven days of that date.

The appellant may file a request for reconsideration in many ways; please note that you need only file *one* request for reconsideration:

- 1. Use your smart phone, tablet, or computer to fill out the "File a Written Argument" form, available on EAB's website: https://www.oregon.gov/EMPLOY/EAB/Pages/default.aspx, or

- 4. Send EAB a fax at 503-378-2129.

DECISION: The application for review filed January 28, 2022 is dismissed without prejudice. Order No. 21-UI-168988 remains undisturbed.
