EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0201

Late Application for Review Dismissed

PROCEDURAL HISTORY: On April 21, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective December 6, 2020. On May 11, 2021, the April 21, 2021 administrative decision became final without claimant having filed a request for hearing. On September 28, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 25, 2021 issued Order No. 21-UI-177953, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 8, 2021. On November 15, 2021, Order No. 21-UI-177953 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB). On February 4, 2022, claimant filed a late application for review of Order No. 21-UI-177953 with the Employment Appeals Board (EAB).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement submitted with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDING OF FACT: (1) Order No. 21-UI-177953, mailed to claimant on October 25, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-177953 at 2. Order No. 21-UI-177953 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 15, 2021."

(2) Claimant was temporarily outside of Oregon and not at their address from sometime after September 28, 2021, when they filed their late request for hearing, until they returned on January 28, 2022. Claimant did not receive Order No. 21-UI-177953 until they returned to their address on January 28, 2022.

(3) On February 4, 2022, claimant submitted their application for review to EAB.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-177953 is dismissed.

An application for review is timely if it is filed within 20 days of the date that OAH mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-177953 was due by November 15, 2021. Because claimant did not file their application for review until February 4, 2022, the application for review was late. Claimant provided a written statement with the application for review. EAB Exhibit 1. In the statement, claimant explained that they did not receive Order No. 21-UI-177953 until January 28, 2022 because they were "temporarily out of state." EAB Exhibit 1 at 1. However, claimant's written statement does not show that claimant's absence from Oregon was a factor or circumstance beyond their control that prevented them from timely filing the application for review. Claimant requested a hearing regarding the April 21, 2021 administrative decision on September 28, 2021. Claimant therefore could reasonably have expected to receive mail regarding that matter after September 28, 2021, which encompassed the time they were outside of Oregon. The record does not show that it was not within claimant's reasonable control to make arrangements to receive their mail or be notified regarding correspondence related to their late request for hearing. Nor did claimant otherwise describe circumstances that prevented them from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed February 4, 2022 is dismissed. Order No. 21-UI-177953 remains undisturbed.
