

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0205**

*Order No. 21-UI-160678 Affirmed ~Request for Hearing Dismissed*  
*Order No. 21-UI-160805 Affirmed ~Request for Hearing Dismissed*

**PROCEDURAL HISTORY:** On January 14, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective December 13, 2020 (decision # 110046). On January 26, 2021, the Department served notice of an administrative decision concluding that claimant was not available for work during the week of December 27, 2020 through January 2, 2021 (week 53-20) and therefore was not eligible to receive benefits for that week (decision # 80635). Claimant filed a timely request for hearing on decision # 80635 and a late request for hearing on decision # 110046. On or prior to February 9, 2021, claimant filed a request to withdraw their hearing request on decision # 80635. ALJ Davis considered claimant's request, and on February 9, 2021 issued Order No. 21-UI-160678, dismissing claimant's request for hearing on decision # 80635, and leaving decision # 80635 undisturbed. On or prior to February 10, 2021, claimant filed a request to withdraw their hearing request on decision # 110046. ALJ Kangas considered claimant's request, and on February 10, 2021 issued Order No. 21-UI-160805, dismissing claimant's request for hearing on decision # 110046, and leaving decision # 110046 undisturbed. On February 27, 2021, claimant filed applications for review of Orders No. 21-UI-160678 and 21-UI-160805 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-160678 and 21-UI-160805. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0205 and 2022-EAB-0206).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

**DECISION:** Orders No. 21-UI-160678 and 21-UI-160805 are affirmed.
