# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0207

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On November 5, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for misconduct, disqualifying claimant from receiving unemployment insurance benefits effective August 29, 2021 (decision # 144413). Claimant filed a timely request for hearing. On December 7, 2021, ALJ Amesbury conducted a hearing, and on December 8, 2021 issued Order No. 21-UI-181414, affirming decision # 144413. On December 28, 2021, Order No. 21-UI-181414 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On January 25, 2022, claimant filed a late application for review of Order No. 21-UI-181414 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's petition for judicial review to the Court of Appeals and her additional written statement provided with her application for review, and have been marked as EAB Exhibits 1 and 2, respectively, and copies provided to the parties with this decision. Any party that objects to our admitting EAB Exhibits 1 and 2 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibits will remain in the record.

**FINDING OF FACT:** (1) Order No. 21-UI-181414, mailed to claimant on December 8, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-181414 at 5. Order No. 21-UI-181414 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before December 8, 2021 to be timely."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-181414 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR

471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-181414 was due by December 28, 2021. Because claimant did not file their application for review until January 25, 2022, the application for review was late. Claimant provided a written statement with the application for review. However, claimant's written statement did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed January 25, 2022 is dismissed. Order No. 21-UI-181414 remains undisturbed.
