

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0221

Affirmed
No Disqualification

PROCEDURAL HISTORY: On December 23, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that the employer discharged claimant for committing a disqualifying act under the Department's drug, cannabis, and alcohol adjudication policy, disqualifying claimant from receiving unemployment insurance benefits effective November 28, 2021 (decision # 124719). Claimant filed a timely request for hearing. On February 1, 2022, ALJ Janzen conducted a hearing, and on February 2, 2022 issued Order No. 22-UI-185366, reversing decision # 124719 by concluding that claimant was discharged, but not for committing a disqualifying act, and was not disqualified from receiving benefits based on the work separation. On February 10, 2022, the employer filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: The employer did not declare that they provided a copy of their argument to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-185366 is affirmed.
