# EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0227

Late Application for Review Dismissed

**PROCEDURAL HISTORY:** On July 6, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant had failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of June 13, 2021 through June 19, 2021 (week 24-21) and until the reason for the denial had ended. On July 26, 2021, the July 6, 2021 administrative decision became final without claimant having filed a request for hearing. On October 21, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 25, 2021 issued Order No. 21-UI-177981, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 8, 2021. On November 15, 2021, Order No. 21-UI-177981 became final without claimant having responded to the appellant questionnaire or filed an application for review with the Employment Appeals Board (EAB). On November 29, 2021, claimant filed a late response to the appellant questionnaire and a late application for review of Order No. 21-UI-177981 with EAB. On February 8, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding this matter because the questionnaire response was late. This matter comes before EAB based upon claimant's November 29, 2021 application for review of Order No. 21-UI-177981.

**FINDING OF FACT:** (1) Order No. 21-UI-177981, mailed to claimant on October 25, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-177981 at 2. Order No. 21-UI-177981 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 15, 2021."

**CONCLUSIONS AND REASONS:** Claimant's late application for review of Order No. 21-UI-177981 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or

circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-177981 was due by November 15, 2021. Because claimant did not file their application for review until November 29, 2021, the application for review was late. Claimant's application for review did not include a written statement describing the circumstances that prevented them from filing the application for review by the November 15, 2021 deadline. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

**DECISION:** The application for review filed November 29, 2021 is dismissed. Order No. 21-UI-177981 remains undisturbed.
