EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0229

Late Application for Review Dismissed

PROCEDURAL HISTORY: On August 30, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Mixed Earner Unemployment Compensation (MEUC) concluding that claimant was not eligible for MEUC benefits effective December 27, 2020. Claimant filed a timely request for hearing. On January 3, 2022, ALJ Lohuis conducted a hearing, and on January 11, 2022 issued Order No. 22-UI-183798, reversing the August 30, 2021 administrative decision by concluding that claimant was eligible for MEUC benefits. On January 31, 2022, Order No. 22-UI-183798 became final without the Department having filed an application for review with the Employment Appeals Board (EAB). On February 11, 2022, the Department filed a late application for review of Order No. 22-UI-183798 with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of a statement included with the Department's application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit(s) will remain in the record.

WRITTEN ARGUMENT: The Department did not declare that they provided a copy of their argument that Order No. 22-UI-183798 should be reversed to the opposing party or parties as required by OAR 471-041-0080(2)(a) (May 13, 2019). The argument also contained information that was not part of the hearing record, did not show that factors or circumstances beyond the Department's reasonable control prevented them from offering the information during the hearing, and was not relevant and material to EAB's determination, as required by OAR 471-041-0090 (May 13, 2019). EAB considered only information received into evidence at the hearing when reaching this decision. *See* ORS 657.275(2).

FINDING OF FACT: (1) Order No. 22-UI-183798, served on the Department by electronic notification on January 11, 2022, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 22-UI-183798 at 5. Order No. 22-UI-183798 also stated on its Certificate of Mailing, "Any appeal from this Order must be filed on or before January 31, 2022 to be timely."

CONCLUSIONS AND REASONS: The Department's late application for review of Order No. 22-UI-183798 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 22-UI-183798 was due by January 31, 2022. Because the Department did not file their application for review until February 11, 2022, the application for review was late. In the statement included with the application for review, the Department explained that they filed the application for review late due to "the unprecedented workload associated with the COVID-19 pandemic" and that "an administrative backlog does continue to impact the reasonable ability to review and respond to all issues promptly." EAB Exhibit 1 at 1. The Department also explained that "the circumstances preventing the timely filing [of the application for review] ceased to exist when the Order was reviewed by [the Department's] tax department and then referred to UI Operations for the possible EAB review on February 7, 2022." EAB Exhibit 1 at 1.

While the Department's report of a heavy workload does adequately explain why the application for review was late, the Department has not shown that the workload constituted circumstances beyond their reasonable control that prevented a timely filing. The Department may have little control over the volume of their workload, and may likewise have a larger volume of work than can be completed timely. However, it is reasonable to presume, in the absence of facts to the contrary, that the Department nevertheless reserves the ability to *prioritize* the order in which they complete their work. That the Department did not prioritize the timely filing of this application for review in order to complete other work first may have been an understandable choice, given the "administrative backlog" and, presumably, limited staff available to clear that backlog. The Department's choice not to prioritize the timely filing of the application for review therefore was within their reasonable control, and not, as they argued, beyond their reasonable control.

Accordingly, the Department did not show good cause for the late application for review, and the Department's late application for review is dismissed.

DECISION: The application for review filed February 11, 2022 is dismissed. Order No. 22-UI-183798 remains undisturbed.
