

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0234-R

Request for Reconsideration Dismissed
EAB Decision 2022-EAB-0234 Remains Undisturbed

PROCEDURAL HISTORY: On December 21, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective December 29, 2019 (decision # 111533). Claimant filed a timely request for hearing. On January 24, 2022, ALJ Davis conducted a hearing, and on January 25, 2022 issued Order No. 22-UI-184759, affirming decision # 111533. On February 11, 2022, claimant filed an application for review with the Employment Appeals Board (EAB). On April 15, 2022, EAB issued EAB Decision 2022-EAB-0234, affirming Order No. 22-UI-184759, and mailed the decision to claimant. On April 26, 2022, claimant filed a request for reconsideration with EAB.

This decision is issued pursuant to EAB's authority under ORS 657.290(3).

CONCLUSIONS AND REASONS: Claimant's request for reconsideration is dismissed.

ORS 657.290(3) authorizes EAB to reconsider any previous decision of EAB, including "the making of a new decision to the extent necessary and appropriate for the correction of previous error of fact or law." "Any party may request reconsideration to correct an error of material fact or law, or to explain any unexplained inconsistency with Employment Department rule, or officially stated Employment Department position, or prior Employment Department practice." OAR 471-041-0145(1) (May 13, 2019). The request is subject to dismissal unless it includes a statement that a copy was provided to the other parties, and is filed on or before the 20th day after the decision sought to be reconsidered was mailed. OAR 471-041-0145(2).

EAB issued EAB Decision 2022-EAB-0234 on April 15, 2022. Claimant filed her request for reconsideration on April 26, 2022, less than 20 days after EAB Decision 2022-EAB-0234 was mailed. However, claimant's request for reconsideration did not include any statement that claimant provided a copy of the request for reconsideration to the employer as required. Claimant's request is therefore dismissed.

DECISION: The request for reconsideration filed April 26, 2022 is dismissed. Employment Appeals Board Decision 2022-EAB-0234 remains undisturbed.
