EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0252

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On January 19, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving unemployment insurance benefits effective June 30, 2019 (decision # 144752). On February 3, 2021, the Department served notice of another administrative decision concluding that claimant voluntarily quit work without good cause and was disqualified from receiving benefits effective June 14, 2020 (decision #80615). On February 8, 2021, decision # 144752 became final without claimant having filed a request for hearing. On February 23, 2021, decision #80615 became final without claimant having filed a request for hearing. On September 15, 2021, claimant filed late requests for hearing on decisions #144752 and 80615. ALJ Kangas considered claimant's requests, and on November 2, 2021 issued Order No. 21-UI-178685 dismissing claimant's request for hearing on decision # 144752 as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 16, 2021. On November 3, 2021, ALJ Kangas issued Order No. 21-UI-178942, dismissing claimant's request for hearing on decision #80615 as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 17, 2021. On November 22, 2021, Order No. 21-UI-178685 became final without claimant having filed an appellant questionnaire response or application for review of Order No. 21-UI-178685 with the Employment Appeals Board (EAB). On November 23, 2021, Order No. 21-UI-178942 became final without claimant having filed an appellant questionnaire response or application for review of Order No. 21-UI-178942 with EAB. On February 18, 2022, claimant filed late applications for review of Orders No. 21-UI-178685 and 21-UI-178942 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-178685 and 21-UI-178942. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0253 and 2022-EAB-0252).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such

objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 21-UI-178685, mailed to claimant on November 2, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-178685 at 2. Order No. 21-UI-178685 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 22, 2021."

(2) Order No. 21-UI-178942, mailed to claimant on November 3, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-178942 at 2. Order No. 21-UI-178942 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 23, 2021."

CONCLUSIONS AND REASONS: Claimant's late applications for review of Orders No. 21-UI-178685 and 21-UI-178942 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-178685 was due by November 22, 2021. The application for review of Order No. 21-UI-178942 was due by November 23, 2021. Because claimant did not file their applications for review until February 18, 2022, the applications for review were late. Claimant provided a written statement with the applications for review. EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review of Orders No. 21-UI-178685 and 21-UI-178942 are dismissed.

DECISION: The applications for review filed February 18, 2022 are dismissed. Orders No. 21-UI-178685 and 21-UI-178942 remain undisturbed.
