

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0267**

*Late Application for Review Dismissed*

**PROCEDURAL HISTORY:** On June 3, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain unemployment insurance benefits, and assessing a \$12,831 overpayment that claimant was required to repay, a \$813.40 monetary penalty, and a 30-week penalty disqualification from future benefits. On June 23, 2021, the June 3, 2021 administrative decision became final without claimant having filed a request for hearing. On July 20, 2021, claimant filed a late request for hearing on the June 3, 2021 administrative decision. ALJ Kangas considered claimant's request, and on August 3, 2021 issued Order No. 21-UI-171710, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by August 17, 2021. On August 11, 2021, claimant filed a timely response to the appellant questionnaire. On October 6, 2021, the Office of Administrative Hearings (OAH) mailed a letter stating that Order No. 21-UI-171710 was vacated and that a new hearing would be scheduled to determine whether claimant's late request for hearing on the June 3, 2021 administrative decision should be allowed, and if so, the merits of that decision. On November 8, 2021, ALJ Frank conducted a hearing, and on November 16, 2021 issued Order No. 21-UI-179824, allowing claimant's late request for hearing and modifying the June 3, 2021 administrative decision by concluding that claimant was liable a \$174 overpayment of regular benefits, was not liable for an overpayment of Federal Pandemic Unemployment Compensation (FPUC) benefits, and was not subject to a monetary penalty or penalty disqualification from future benefits. On December 6, 2021, Order No. 21-UI-179824 became final without claimant having filed an application for review with the Employment Appeals Board (EAB). On February 24, 2022, claimant filed a late application for review of Order No. 21-UI-179824 with EAB.

**EVIDENTIARY MATTER:** EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence consists of claimant's written statement and supporting documents submitted with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

**FINDING OF FACT:** (1) Order No. 21-UI-179824, mailed to claimant on November 16, 2021, stated, “You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed.” Order No. 21-UI-179824 at 10. Order No. 21-UI-179824 also stated on its Certificate of Mailing, “Any appeal from this Order must be filed on or before December 6, 2021 to be timely.”

**CONCLUSIONS AND REASONS:** Claimant’s late application for review of Order No. 21-UI-179824 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a “reasonable time” upon a showing of “good cause.” ORS 657.875; OAR 471-041-0070(2). “Good cause” means that factors or circumstances beyond the applicant’s reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A “reasonable time” is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-179824 was due by December 6, 2021. Because claimant did not file their application for review until February 24, 2022, the application for review was late. Claimant provided a written statement with the application for review. In her statement, claimant appears to take issue with a recent bill she received from the Department which sought to collect an \$1,800 overpayment for Lost Wages Assistance (LWA) benefits. EAB Exhibit 1 at 1-3. From the statement, it appears that claimant believes that she should not be subject to an \$1,800 overpayment for LWA benefits due to the result that was reached in Order No. 21-UI-179824. EAB Exhibit 1 at 1-3. Regardless, claimant’s written statement did not describe the circumstances that prevented claimant from filing an application for review of Order No. 21-UI-179824 on time. Accordingly, claimant did not show good cause for the late application for review, and claimant’s late application for review is dismissed.

**DECISION:** The application for review filed February 24, 2022 is dismissed. Order No. 21-UI-179824 remains undisturbed.
