

**EMPLOYMENT APPEALS BOARD DECISION**  
**2022-EAB-0272**

*Affirmed*  
*No Disqualification*

**PROCEDURAL HISTORY:** On December 15, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was discharged by the employer, but not for misconduct, and was not disqualified from receiving unemployment insurance benefits based on the work separation (decision # 135120). The employer filed a timely request for hearing. On February 1, 2022, ALJ Lucas conducted a hearing, and on February 2, 2022 issued Order No. 22-UI-185401, affirming decision # 135120. On February 22, 2022, the employer filed an application for review with the Employment Appeals Board (EAB).

**EVIDENTIARY MATTER:** The record shows that the ALJ erred by not admitting the employer's exhibit, as the employer's witness indicated that they served the exhibit on claimant as required by OAR 471-040-0023(5) (August 1, 2004). Audio Record at 6:03. However, the employer's witness testified to much of the contents of the documents during the hearing, and the remaining information contained in those documents was not material to the outcome of this decision. Thus, under OAR 471-040-0025(5) (August 1, 2004), the record shows that the employer was not prejudiced by the ALJ's failure to admit the exhibit, and it therefore is unnecessary to remand in order to take additional evidence based on the employer's exhibit.

**WRITTEN ARGUMENT:** The employer's argument contained information that was not part of the hearing record,<sup>1</sup> and did not show that factors or circumstances beyond the employer's reasonable control prevented them from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered the employer's argument to the extent it was based on the record.

<sup>1</sup> The documents attached to the employer's written argument consisted, in part, of documents originally offered as part of the employer's exhibit but not admitted at hearing, as addressed above. For purposes of this decision, the "information that was not part of the hearing record" consisted of the documents that the employer did not offer into evidence at the hearing.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

**DECISION:** Order No. 22-UI-185401 is affirmed.
