

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0280

Affirmed

Ineligible for PUA Weeks 11-20 through 16-20, 53-20 through 28-21, and 31-21

PROCEDURAL HISTORY: On January 3, 2022, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits for the weeks from February 2, 2020 through December 5, 2020 because he filed his application for PUA benefits after December 27, 2020. On January 7, 2022, the Department served a Notice of Determination for PUA concluding that claimant was not entitled to receive PUA benefits effective December 6, 2020 because he filed his application for PUA benefits after October 6, 2021. Claimant filed a timely request for hearing on both decisions. On February 8, 2022, ALJ Janzen conducted a consolidated hearing, and on February 9, 2022, issued Order No. 22-UI-185949 affirming the January 3, 2022 administrative decision by concluding that claimant was not eligible for PUA benefits for the weeks from March 8, 2020 through April 18, 2020 (weeks 11-20 through 16-20). Also on February 9, 2022, ALJ Janzen issued Order No. 22-UI-185948 affirming the January 7, 2022 administrative decision by concluding that claimant was not eligible for PUA benefits for the weeks from March 8, 2020 through April 18, 2020, December 27, 2020 through July 17, 2021, and August 1, 2021 through August 7, 2021 (weeks 11-20 through 16-20, 53-20 through 28-21, and 31-21). On February 28, 2022, claimant filed applications for review of Orders No. 22-UI-185949 and 22-UI-185948 with the Employment Appeals Board (EAB).

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-185949 and 22-UI-185948. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0280 and 2022-EAB-0279).

EAB reviewed the entire consolidated hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-185949 and 22-UI-185948 are affirmed.
