

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0286

Affirmed
Ineligible Weeks 32-21 and 33-21

PROCEDURAL HISTORY: On August 27, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of August 8, 2021 through August 14, 2021 (week 32-21), and until the reason for the denial had ended. On September 7, 2021, the Department served notice of an administrative decision concluding that claimant failed to provide information necessary to process their claim as requested by the Department and therefore was denied benefits for the week of August 15, 2021 through August 21, 2021 (week 33-21), and until the reason for denial had ended (decision # 113324). Claimant filed a timely request for hearing on the August 27, 2021 administrative decision and decision # 113324. On October 6, 2021, the Office of Administrative Hearings (OAH) served, by mail, notice of a consolidated telephone hearing scheduled for October 21, 2021 at 1:30 p.m. on the August 27, 2021 administrative decision and decision # 113324. On October 21, 2021, claimant failed to appear at the consolidated hearing, and ALJ Scott issued Orders No. 21-UI-177757 and 21-UI-177756, dismissing claimant's requests for hearing on the August 27, 2021 administrative decision and decision # 113324, respectively, for failure to appear. On November 10, 2021, Orders No. 21-UI-177757 and 21-UI-177756 became final without claimant having filed a request to reopen the October 21, 2021 consolidated hearing, or an application for review of Orders No. 21-UI-177757 and 21-UI-177756 with the Employment Appeals Board (EAB).

On February 4, 2022, claimant filed a late request to reopen the October 21, 2021 consolidated hearing. ALJ Kangas reviewed claimant's request to reopen, and on February 16, 2022, issued Orders No. 22-UI-186642 and 22-UI-186641, denying the request and leaving Orders No. 21-UI-177757 and 21-UI-177756 undisturbed. On March 1, 2022, claimant filed applications for review of Orders No. 22-UI-186642 and 22-UI-186641 with EAB.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 22-UI-186642 and 22-UI-186641. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0287 and 2022-EAB-0286).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the orders under review are **adopted**.

DECISION: Orders No. 22-UI-186642 and 22-UI-186641 are affirmed.
