EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0290

Affirmed
Ineligible Weeks 31-21 through 33-21

PROCEDURAL HISTORY: On August 27, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of August 1, 2021 through August 7, 2021 (week 31-21) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On February 15, 2022, ALJ Demarest conducted a hearing, and on February 18, 2022 issued Order No. 22-UI-186484, modifying the August 27, 2021 administrative decision by concluding that claimant was ineligible for benefits for the weeks including August 1, 2021 through August 21, 2021 (weeks 31-21 through 33-21). On March 2, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented her from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

FINDINGS OF FACT: (1) On April 8, 2020, claimant filed an initial claim for unemployment insurance benefits.

- (2) On or about July 9, 2021, the Department mailed claimant a letter that notified her that, in order to be eligible to receive benefits, she was required to complete the Department's iMatchSkills registration process by July 24, 2021. The letter stated if claimant was not currently filing weekly claims for benefits, she did not have to register, but if claimant restarted her claim, she would have to complete the registration process at that time to be eligible to receive benefits.
- (3) Claimant received the Department's letter and was aware of the July 24, 2021 deadline. However, claimant did not notice the portion of the letter that stated if claimant restarted her claim, she would have to complete the registration process at that time. Claimant worked throughout the month of July 2021

and did not file weekly claims for benefits, and therefore decided that she did not need to complete the iMatchSkills registration process.

- (4) On August 6, 2021, claimant restarted her claim but did not register for iMatchSkills. Claimant claimed benefits for the weeks including August 1, 2021 through August 21, 2021 (weeks 31-21 through 33-21). These are the weeks at issue. The Department did not pay claimant benefits for the weeks at issue.
- (5) On August 28, 2021, after speaking to a Department representative, claimant completed the iMatchSkills registration process.

CONCLUSIONS AND REASONS: Claimant did not register for work in accordance with the Department's rules and therefore was ineligible for benefits for the weeks including August 1, 2021 through August 21, 2021 (weeks 31-21 through 33-21).

ORS 657.155(1)(a) states that an unemployed individual is eligible to receive benefits only if the individual has registered for work and thereafter continued to report at an employment office in accordance with Department rules. ORS 657.159 states that to satisfy the registration requirement of ORS 657.155(1) an individual shall submit such information regarding the individual's job qualifications, training and experience as the Department requests.

OAR 471-030-0035 (January 11, 2018) states in relevant part:

- (1) A claimant may fulfill the "registered for work" requirements of ORS 657.155(1)(a) by completion of such processes as directed by the Director in order to create a full registration for work.
- (2) "Full registration for work" as used in this rule, means providing information regarding the individual's job qualifications, skills, training and experience as the Director or an authorized representative of the Director deems necessary to carry out job placement services for the individual.

* * *

OAR 471-020-0020 (August 8, 2004) states in relevant part:

(1)(a) Except for individuals identified in OAR 471-020-0021, all unemployment insurance claimants shall submit such information as may be required by the Oregon Employment Department to carry out job placement services for the individual including, but not limited to, the individual's job qualifications, training and experience. Such information shall be entered into the Business & Employment Services online job match system concurrent with, or as soon as possible following, the filing of an initial claim for unemployment insurance benefits. Entry of this information shall constitute enrollment.

* * *

Because the Department did not pay claimant benefits for the weeks at issue, claimant has the burden to show that she was eligible for benefits for those weeks. *See Nichols v. Employment Division*, 24 Or App 195, 544 P2d 1068 (1976) (where the Department has paid benefits it has the burden to prove benefits should not have been paid; by logical extension of that principle, where benefits have not been paid claimant has the burden to prove that the Department should have paid benefits).

The record shows that the Department notified claimant that she needed to complete her iMatchSkills registration by July 24, 2021, or, if she was not currently filing weekly claims for benefits, at the time that she restarted her claim. Claimant received this notification, and restarted her claim on August 6, 2021, but did not complete her iMatchSkills registration until August 28, 2021, which was after the weeks at issue. Because claimant did not register for work in accordance with the Department's rules during the weeks at issue, claimant was not eligible to receive benefits for those weeks under ORS 657.155(1)(a).

At hearing, claimant testified that it "slipped her mind or [she] overlooked" the instruction in the letter to complete iMatchSkills registration at the time she restarted her claim. Audio Record at 21:49. However, there is no "good cause" exception to the Department's registration requirement in the applicable administrative rules or statutes. Therefore, because claimant did not complete the iMatchSkills registration requirement until August 28, 2021, claimant was ineligible for benefits for the weeks at issue.

DECISION: Order No. 22-UI-186848 is affirmed.
