EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0296

Affirmed Late Request for Hearing Dismissed

PROCEDURAL HISTORY: On January 15, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits for the weeks from April 5, 2020 through August 15, 2020 (weeks 15-20 through 33-20). On February 4, 2021, the January 15, 2021 administrative decision became final without claimant having filed a request for hearing. On November 23, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on November 29, 2021 issued Order No. 21-UI-180567, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by December 13, 2021. On December 4, 2021, claimant filed a timely response to the appellant questionnaire. ALJ Kangas considered claimant's response, and on February 24, 2022 issued Order No. 22-UI-187127, canceling Order No. 21-UI-180567 and re-dismissing claimant's request for hearing on the January 15, 2021 administrative decision as late without good cause. On March 2, 2022, claimant filed an application for review of Order No. 21-UI-187127 with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: EAB considered claimant's written argument in reaching this decision.

FINDINGS OF FACT: (1) On January 15, 2021, the Department mailed an administrative decision to claimant's address on file with the Department. The decision stated, "You have the right to appeal this decision if you do not believe it is correct. Your request for appeal must be received by February 4, 2021." Exhibit 1 at 2.

CONCLUSIONS AND REASONS: Claimant's late request for hearing is dismissed.

ORS 657.269 provides that the Department's decisions become final unless a party files a request for hearing within 20 days after the date the decision is mailed. ORS 657.875 provides that the 20-day deadline may be extended a "reasonable time" upon a showing of "good cause." OAR 471-040-0010 (February 10, 2012) provides that "good cause" includes factors beyond an applicant's reasonable control or an excusable mistake, and defines "reasonable time" as seven days after those factors ceased to exist.

Claimant's request for hearing on the January 15, 2021 administrative decision was late. The request for hearing on that decision was due by February 4, 2021. Claimant did not file their request for hearing until November 23, 2021.

With their questionnaire response, claimant submitted a copy of the January 15, 2021 administrative decision, and noted on that decision that they were "not appealing" the decision's determination that claimant was "not entitled to PUA for the period from April 5, 2020 through August 15, 2020." Exhibit 3 at 7. In doing so, the claimant's response shows that claimant did not disagree with the January 15, 2021 administrative decision and did not intend to request a hearing on that decision. Claimant's questionnaire response also shows that claimant disagreed with an administrative decision dated November 15, 2021 and that claimant intended to request a hearing on that decision. Exhibit 3 at 5-6. However, only the January 15, 2021 administrative decision, and not the November 15, 2021 administrative decision, is within the jurisdiction of this proceeding. Because claimant's questionnaire responses are primarily regarding a different administrative decision that is not at issue in this matter, the responses do not show that claimant failed to request a hearing on the January 15, 2021 administrative decision due to a factor beyond claimant's reasonable control, or an excusable mistake.

For these reasons, claimant has not shown that they had good cause to extend the deadline to request a hearing on the January 15, 2021 administrative decision. Therefore, claimant's request for hearing is dismissed.

DECISION: Order No. 22-UI-187127 is affirmed.
