

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0297

Affirmed
Ineligible Weeks 52-21 through 02-22

PROCEDURAL HISTORY: On January 18, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive unemployment insurance benefits for the week of December 26, 2021 through January 1, 2022 (week 52-21) and until the reason for the denial had ended. Claimant filed a timely request for hearing. On February 22, 2022, ALJ Ramey conducted a hearing, and on February 24, 2022 issued Order No. 22-UI-187224, modifying¹ the January 18, 2022 administrative decision by concluding that claimant failed to register for work in accordance with the Department's rules and therefore was ineligible to receive benefits for the weeks from December 26, 2021 through January 15, 2022 (weeks 52-21 through 02-22). On March 2, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-187224 is affirmed.
