EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0303

Late Application for Review Dismissed

PROCEDURAL HISTORY: On June 18, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant quit working for the employer without good cause and was disqualified from receiving unemployment insurance benefits effective September 20, 2020 (decision #73749). On July 8, 2021, decision #73749 became final without claimant having filed a request for hearing. On October 14, 2021, claimant filed a late request for hearing. ALJ Kangas considered claimant's request, and on October 18, 2021 issued Order No. 21-UI-177399, dismissing the request as late, subject to claimant's right to renew the request by responding to an appellant questionnaire by November 1, 2021. On November 9, 2021, the Office of Administrative Hearings (OAH) mailed Order No. 21-UI-177399 to claimant's new address. On November 29, 2021, Order No. 21-UI-177399 became final without claimant having filed a response to the appellant questionnaire or an application for review with the Employment Appeals Board (EAB).¹ On December 13, 2021, claimant filed a late response to the appellant questionnaire with OAH and a late application for review with EAB. On March 1, 2022, ALJ Kangas mailed a letter to claimant stating that because claimant's response to the appellant questionnaire was late, it would not be considered, another order would not be issued, and Order No. 21-UI-177399 remained in effect. This matter comes before EAB based on claimant's December 13, 2021 late application for review with EAB.

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is the written statement and associated documents claimant provided with their application for review, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

¹ Using the mailing date of November 9, 2021, claimant's response to the appellant questionnaire was due by November 23, 2021, and an application for review with the Employment Appeals Board was due by November 29, 2021.

FINDINGS OF FACT: (1) Order No. 21-UI-177399, mailed to claimant on October 18, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Exhibit 1 at 2.

(2) Order No. 21-UI-177399 was returned to OAH by the postal service. On November 9, 2021, after confirming claimant's new address, OAH mailed claimant another copy of Order No. 21-UI-177399.

CONCLUSIONS AND REASONS: Claimant's late application for review of Order No. 21-UI-177399 is dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The application for review of Order No. 21-UI-177399 was due by November 29, 2021. Because claimant did not file their application for review until December 13, 2021, the application for review was late. Claimant provided a written statement with the application for review. *See* EAB Exhibit 1 at 6-7. However, claimant's written statement did not describe circumstances that prevented claimant from filing the application for review on time. Accordingly, claimant did not show good cause for the late application for review, and claimant's late application for review is dismissed.

DECISION: The application for review filed December 13, 2021 is dismissed. Order No. 21-UI-177399 remains undisturbed.
