EMPLOYMENT APPEALS BOARD DECISION 2022-EAB-0308

Late Applications for Review Dismissed

PROCEDURAL HISTORY: On August 23, 2021, the Oregon Employment Department (the Department) served a Notice of Determination for Pandemic Unemployment Assistance (PUA) concluding that claimant was not entitled to receive PUA benefits effective December 27, 2020. On September 13, 2021, the August 23, 2021 administrative decision became final without claimant having filed a timely request for hearing. On September 14, 2021, the Department served notice of an administrative decision, based in part on the August 23, 2021 administrative decision, concluding that claimant willfully made a misrepresentation and failed to report a material fact to obtain benefits, and assessing a \$26,685 overpayment of PUA and Federal Pandemic Unemployment Compensation (FPUC) benefits, a \$1,800 overpayment of Lost Wages Assistance (LWA), and a \$4,002.75 monetary penalty. On October 4, 2021, the September 14, 2021 overpayment decision became final without claimant having filed a timely request for hearing. On October 13, 2021, claimant filed late requests for hearing on the August 23, 2021 administrative decision became final without claimant

ALJ Kangas considered claimant's late requests for hearing, and on November 8, 2021 issued Orders No. 21-UI-179293 and 21-UI-179298, dismissing claimant's requests for hearing on the August 23, 2021 administrative decision and the September 14, 2021 overpayment decision as untimely, subject to claimant's right to renew the requests by responding to appellant questionnaires by November 22, 2021. On November 29, 2021, Orders No. 21-UI-179293 and 21-UI-179298 became final without claimant having responded to the appellant questionnaires or filed applications for review of the orders with the Employment Appeals Board (EAB). On December 2, 2021, claimant filed a late response to the appellant questionnaire and late applications for review of Orders No. 21-UI-179298 with EAB. On February 20, 2022, ALJ Kangas mailed a letter stating that the Office of Administrative Hearings (OAH) would not consider claimant's questionnaire response or issue another order regarding claimant's late request for hearing on the August 23, 2021 administrative decision or the September 14, 2021 overpayment decision because the questionnaire response was late.

Pursuant to OAR 471-041-0095 (October 29, 2006), EAB consolidated its review of Orders No. 21-UI-179293 and 21-UI-179298. For case-tracking purposes, this decision is being issued in duplicate (EAB Decisions 2022-EAB-0308 and 2022-EAB-0307).

EVIDENTIARY MATTER: EAB has considered additional evidence when reaching this decision under OAR 471-041-0090(1) (May 13, 2019). The additional evidence is claimant's response to the appellant questionnaire, and has been marked as EAB Exhibit 1, and a copy provided to the parties with this decision. Any party that objects to our admitting EAB Exhibit 1 must submit such objection to this office in writing, setting forth the basis of the objection in writing, within ten days of our mailing this decision. OAR 471-041-0090(2). Unless such objection is received and sustained, the exhibit will remain in the record.

FINDINGS OF FACT: (1) Order No. 21-UI-179293, mailed to claimant on November 8, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-179293 at 2. Order No. 21-UI-179293 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 29, 2021."

(2) Order No. 21-UI-179298, mailed to claimant on November 8, 2021, stated, "You may appeal this decision by filing the attached form Application for Review with the Employment Appeals Board within 20 days of the date that this decision is mailed." Order No. 21-UI-179298 at 2. Order No. 21-UI-179298 also stated on its Certificate of Mailing, "Any party may appeal this Order by filing a Request for Review with the Employment Appeals Board no later than November 29, 2021."

CONCLUSIONS AND REASONS: Claimant's late applications for review of Orders No. 21-UI-179293 and 21-UI-179298 are dismissed.

An application for review is timely if it is filed within 20 days of the date that the Office of Administrative Hearings (OAH) mailed the order for which review is sought. ORS 657.270(6); OAR 471-041-0070(1) (May 13, 2019). The 20-day filing period may be extended a "reasonable time" upon a showing of "good cause." ORS 657.875; OAR 471-041-0070(2). "Good cause" means that factors or circumstances beyond the applicant's reasonable control prevented timely filing. OAR 471-041-0070(2)(a). A "reasonable time" is seven days after the circumstances that prevented the timely filing ceased to exist. OAR 471-041-0070(2)(b). A late application for review will be dismissed unless it includes a written statement describing the circumstances that prevented a timely filing. OAR 471-041-0070(3).

The applications for review of Orders No. 21-UI-179293 and 21-UI-179298 were due by November 29, 2021. Because claimant did not file their applications for review until December 2, 2021, the applications for review were late. Claimant provided a written statement with the applications for review. *See* EAB Exhibit 1. However, claimant's written statement did not describe the circumstances that prevented them from filing the applications for review on time. Accordingly, claimant did not show good cause for the late applications for review, and claimant's late applications for review are dismissed.

DECISION: The applications for review filed December 2, 2021 are dismissed. Orders No. 21-UI-179293 and 21-UI-179298 remain undisturbed.
