

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0316

Affirmed
Ineligible Weeks 03-22 through 06-22

PROCEDURAL HISTORY: On January 25, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was not available for work beginning January 16, 2022 (week 03-23) and therefore was not eligible to receive unemployment insurance benefits for that week and until the reason for the denial had ended (decision # 84048). Claimant filed a timely request for hearing. On February 28, 2022, ALJ Kaneshiro conducted a hearing and issued Order No. 22-UI-187418, modifying decision # 84048 by concluding that claimant was not available for work for the weeks from January 16, 2022 through February 12, 2022 (weeks 03-23 through 06-22) and therefore was not eligible to receive benefits for those weeks. On March 7, 2022, claimant filed an application for review with the Employment Appeals Board (EAB).

WRITTEN ARGUMENT: Claimant's argument contained information that was not part of the hearing record, and did not show that factors or circumstances beyond claimant's reasonable control prevented him from offering the information during the hearing. Under ORS 657.275(2) and OAR 471-041-0090 (May 13, 2019), EAB considered only information received into evidence at the hearing when reaching this decision. EAB considered claimant's argument to the extent it was based on the record.

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-187418 is affirmed.
