

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0323

Application for Review Dismissed
No Justiciable Controversy

PROCEDURAL HISTORY: On October 12, 2021, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant did not actively seek work during the weeks including July 25, 2021 through September 4, 2021 (weeks 30-21 through 35-21) and was therefore not eligible to receive unemployment insurance benefits for those weeks (decision # 82143). Claimant filed a timely request for hearing. On February 18, 2022, ALJ Murdock conducted a hearing, and on February 25, 2022 issued Order No. 22-UI-187363, modifying decision # 82143 by concluding that claimant did actively seek work during the weeks including July 25, 2021 through August 7, 2021 (weeks 30-21 through 31-21) and August 22, 2021 through September 4, 2021 (weeks 34-21 through 35-21) and was eligible to receive benefits for those weeks, but that claimant did not actively seek work during the weeks including August 8, 2021 through August 21, 2021 (weeks 32-21 through 33-21) and was therefore not eligible to receive benefits for those weeks. On March 8, 2022, claimant filed an application for review with the Employment Appeals Board (EAB). On March 11, 2022, the Department served notice of an administrative decision, based on new information, concluding that claimant did actively seek work during the weeks including August 8, 2021 through August 21, 2021 (weeks 32-21 through 33-21) and was not ineligible to receive benefits for those weeks on that basis (decision # 81845).

CONCLUSIONS AND REASONS: Claimant's application for review of Order No. 22-UI-187363 presents no justiciable controversy and is dismissed.

On March 8, 2022, claimant filed with EAB an application for review of Order No. 22-UI-187363, an order that denied claimant benefits for the weeks including August 8, 2021 through August 21, 2021 (weeks 32-21 through 33-21) on the basis that claimant did not actively seek work during those weeks. However, on March 11, 2022, the Department issued decision # 81845, which concluded, based on new information, that claimant did actively seek work during weeks 32-21 and 33-21 and was not ineligible to receive benefits for those weeks on that basis. Accordingly, there is no justiciable controversy before EAB based upon claimant's application for review of Order No. 22-UI-187363. *See accord Barcik v. Kubiacyk*, 321 Or 174, 895 P2d 765 (1995). Because the case before EAB presents no justiciable controversy, the application for review of Order No. 22-UI-187363 is dismissed.

DECISION: The application for review filed March 8, 2022 is dismissed.
