

EMPLOYMENT APPEALS BOARD DECISION
2022-EAB-0325

Affirmed

Eligible Weeks 42-21 through 43-21, 46-21 through 05-22, and 07-22 through 08-22

PROCEDURAL HISTORY: On January 25, 2022, the Oregon Employment Department (the Department) served notice of an administrative decision concluding that claimant was able to work, available for work, and actively seeking work during the weeks from October 17, 2021 through January 15, 2022 (weeks 42-21 through 02-22) and therefore was eligible for unemployment insurance benefits for those weeks (decision # 130021). The employer filed a timely request for hearing. On March 7, 2022, ALJ Mott conducted a hearing, and on March 8, 2022 issued Order No. 22-UI-188091, modifying decision # 130021 by concluding that claimant was able to work and available for work during the weeks from October 17, 2021 through October 30, 2021 (weeks 42-21 through 43-21), November 14, 2021 through February 5, 2022 (weeks 46-21 through 05-22), and February 13, 2022 through February 26, 2022 (weeks 07-22 through 08-22), and was therefore eligible for benefits for those weeks. On March 10, 2022, the employer filed an application for review with the Employment Appeals Board (EAB).

EAB reviewed the entire hearing record. On *de novo* review and pursuant to ORS 657.275(2), the order under review is **adopted**.

DECISION: Order No. 22-UI-188091 is affirmed.
